The Funds aggregately own 1,666,668 shares of Common Stock. Accordingly, QVT Financial may be deemed to be the beneficial owner of an aggregate amount of 1,666,668 shares of Common Stock, consisting of the shares owned by the Funds.

QVT Financial GP LLC, as General Partner of QVT Financial, may be deemed to beneficially own the same number of shares of Common Stock reported by QVT Financial. QVT Associates GP LLC, as General Partner of the Funds, may be deemed to beneficially own the aggregate number of shares of Common Stock owned by the Funds, and accordingly, QVT Associates GP LLC may be deemed to be the beneficial owner of an aggregate amount of 1,666,668 shares of Common Stock.

An entity affiliated with QVT Financial (the “Additional Holder”) beneficially owns 144,446 shares of Common Stock. Each of QVT Financial, QVT Financial GP LLC, QVT Associates GP LLC and the Funds disclaims beneficial ownership of the shares owned by the Additional Holder.

The percentage disclosed in Item 11 of the Cover Pages for each reporting person is calculated on the basis of (i) 18,376,363 shares of Common Stock outstanding, which was the total number of shares issued and outstanding reported in the Issuer’s Prospectus, filed with the Securities and Exchange Commission on January 13, 2014 and (ii) the number of shares of Common Stock underlying each reporting person’s warrants, pursuant to Rule 13d-3(d)(1)(i).
